**UNLISTED DIRECTOR OPTIONS LAPSE**

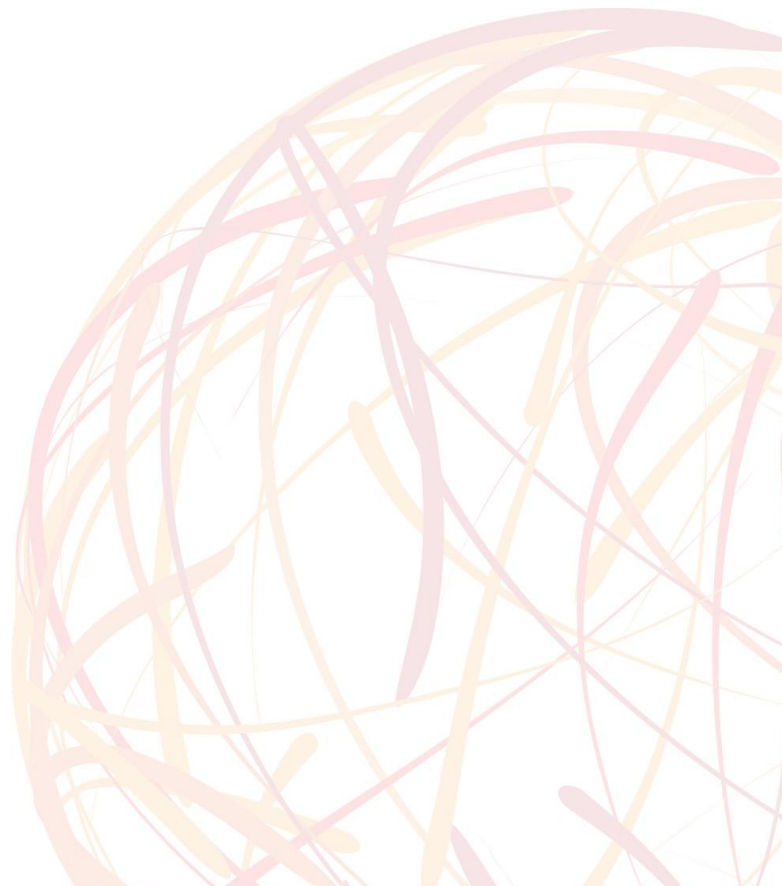
