All remaining liabilities are current and the unusually high level of expenditure that occurred during the December 2020 quarter will not continue.

Answer: Yes the company has successfully raised raise \$800,000 before costs via the issue of 114,285,714 shares at an issue price of \$0.007 per share.

Answer: Yes, additional funds raised will provide sufficient working capital (over two quarters) to allow the business to meet its business objectives.
